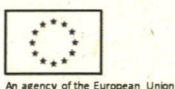



5. Subject to compliance with the foregoing conditions, this approval shall remain valid until:
